Member Recruitment and Retention

The membership committee chairs use the monthly report from WA-ACTE to contact members to rejoin/retention. To assist membership recruitment, the state is divided into 10 sections. At conferences members are asked to identify school changes and new teachers for the membership committee to contact. Each section has a chairperson who keeps an updated list of teachers and schools. Board members in each area are asked to contact new teachers in their region to make a more personal contact and encourage membership. Regions are asked to meet several times a year to network and help each other with frameworks and curriculum.

To encourage membership and professional development, each year two WA-ACTE Summer Conference and two FCS Annual Conference scholarships are available.

Advocacy

We support Say Yes to FCS!, a nation initiative by the American Association of Family and Consumer Sciences. We use their professionally developed materials to speak out for our profession and recruit educators. We work with our Pathway Supervisor at OSPI to advocate for Family and Consumer Sciences she knows through her contacts. She bring to our attention places we can get involved. Though our student leadership organization, Family, Career and Community Leaders of America, we teach advocacy and model it in our communities. Students and teachers participate in the WA-ACTE Legislative Day in Olympia.

Issues

(Including legislative, leadership, partnerships, business and industry, and postsecondary)

Our section has a subscription and several officers, legislative co-chairs and executive director receive WOVE. Information is passed on to members at conference, newsletter articles and email. Our Legislative chairs keep our membership informed of issues needing involvement and quick responses. We partner with AAFCS and the Washington Association of Family and Consumer Sciences on multiple issues and a annual conference in October. Our conference has trainings and workshops with business and industry representative presenting for example: culinary, food science, nutrition, financial education, diabetes education, food safety, teen driver safety, marijuana legalization issues and digital classrooms. Additionally we partner with WA-FCCLA, National FCCLA, MERIT Licensed Child Care Training, TPEP, Careers in Education and GRADS for professional development and updates. Three universities provide FCS teacher education, Washington State University, Seattle Pacific University and Central Washington University. All three universities are represented as both workshop presenters and with postsecondary students attending. Postsecondary students meet as a group prior to the conference. The OSPI Pathway Supervisor and a university representative from the teacher education programs serve on our board as valued ex-officio members.

Marketing

The Say Yes to FCS initiative provided us with marketing tools to use for FACS/CTE recruitment. Workshops and speakers address what we can do to use the materials and welcome people to FACS teaching careers. At Family, Career and Community Leaders of America State and National Conferences, FCS teacher and university students work in a booth/table to answer questions and encourage high school students to become FACS educators.

Posters, handouts, emails and newsletter articles are used. Non-members, non-returning members and FACS university graduates are targeted with assistance of university teacher educators, OSPI Pathway Supervisor and WA-ACTE membership reports. Social media is used for members on Facebook and the Newsletter is sent to all members.

The entire board contributes to a scholarship auction to support university FACS students. Each year we provide a scholarship to the FCCLA State President to attend National FCCLA Leadership

Conference. The Awards committee seeks qualified individuals to be honored. This past year, the awards packet was changed to reflect changes made at WA-ACTE and ACTE.

New and Innovative Ideas

The co-presidents and Executive Director plan and conduct training for new officers and board chairs. Additional training is on-going at each Executive Board meeting. Outgoing officers work with newly elected officers as the transition is made each year. There are two committee chairs and one committee chair continues to train the new person. Chairs work together to create a Program of Work and give updates at each board meeting on their progress.

The Whova app is being used at FCA Annual Conference. Information gathered is valuable for evaluation and planning.
