This Friday marks day 40 of the long legislative session and the cutoff for bills to be heard and passed out of policy committees. After Friday, February 21 we won't see many policy committee meetings until after the fiscal committees have completed their work and House of Origin cutoff has been completed on March 12.

Thursday and Friday will see a flurry of policy bills being heard and exec'd (voted) out of committee to keep them alive as the cutoff calendar begins to show its influence on lawmaker's decisions. There are already fiscal committee hearings scheduled for the weekend, as the fiscal deadline will loom large at the capitol next week.

Bills of Interest

HB 1414 – 16 & 17 year-old Work Group

This bill directs the Office of the Superintendent of Public Instruction, in consultation with the Department of Labor, to establish a work group to recommend changes to state laws surrounding employment of 16- and 17-year-olds enrolled in or who completed Career and Technical Education programs.

The statewide Career and Technical Education task force is established in the Office of the Superintendent of Public Instruction. The members of the task force must include representatives from several entities. We have put together a HB 1414 workgroup list for your curiosity, which includes all members of the work group as spelled out in the bill.

This bill has been tagged with half a million dollar price tag from OSPI which includes money to convene the work group; this means it has an uphill battle this particular year. As a reminder, committee chairs have been told to kill or stall any bills with fiscal notes over \$250,000.

<u>SB 5358 - Career and Technical Education in sixth grade</u> - This bill will get its first fiscal committee hearing this Thursday night (Feb. 20) in Senate Ways and Means. WA-ACTE is scheduled to briefly testify in support of this bill that is supported by a broad coalition. The fiscal note on this bill is about \$1.3 million, but all direct funding to local school districts.

We feel this bill should pass this session as it creates new funding directly at the building level and grows the K-12 pie overall. If we cannot get the funding portion of the bill, we have expressed to the bill sponsor and his office and caucus staff that we are interested in the policy this year without dollars. Feel free to urge your local legislator on the Ways and Means Committee to give this bill and vote and

HB 1167 - Directing the statewide Career and Technical Education task force to consider educational opportunities for careers in maritime professions - On Thursday, February 20 the House Education committee referred this bill to the Rules Committee for its final hurdle before floor passage. With the benefit of "no new" funding, this bill will likely come off the floor successfully before that halftime deadline of March 12. WA-ACTE has supported this bill and testified on its behalf this session.
